Conservation Project



On May 14th and 15th, Chloe Wood completed her conservation Eagle Scout project by hanging six mason bee habitats on the Chapter grounds that were built by her and ScoutsBSA Troop 3017. Members Steve Meyer, John Gallo, Dave Carlson and Preston Wood assisted Chloe with hanging the mason bee habitats. Mason bees are solitary bees that are more efficient pollinators than honeybees; one mason bee can do as much pollinating as 300 honeybees. Mason bee populations have been dwindling and these six habitats will support increasing their numbers. These mason bee habitats are constructed of pallet wood and filled with bamboo tubes sourced from the Chapter grounds for mason bees to inhabit and lay eggs in. This is a new Conservation Committee program to increase mason bee populations in addition to our ongoing Save our Streams initiative testing water quality of our local streams. The Committee will soon begin a butterfly garden conservation program by planting Swamp Milkweed plants that germinated using the cold stratification method. Swamp Milkweed is a vital habitat for the Monarch Butterfly whose numbers have been decreasing at alarming rates. Monarch butterflies lay their eggs on Swamp Milkweed, their larva use the plants for sustenance, and create cocoons on the plants. This butterfly garden will also serve as an educational tool to teach the lifecycle of the Monarch butterfly where one can see eggs, larva, and Monarch chrysalis. To support the bees and butterflies, we will also plant different varieties of wildflowers including a bed to beautify the campground. Any guest using the range must be supervised by a Chapter member with Range Safety Officer credentials. A fee of \$5.00 for each guest is to be paid at the donation box under the sign-in box. **Only one bench may be used by the member and guest.** The same guest may visit the range

only two times a year. The guest fee and two-visit limit do not apply to the immediate family of members.
