### **CHAPTER NEWS**

#### **Conservation Trail Maintenance**

IWLA Frederick #1 Chapter completed maintenance work on the Conservation Trail Saturday, February 10, 2024 from 7:30am to 12pm. Wielding chainsaw, branch loppers, and hedge clippers, we cleared trees that have fallen across the path, painted blazes to mark the trail, and moved the Conservation Trail that is parallel to the neighboring horse trail so that it does not encroach upon the horse trail. Work was completed right at 12pm just before the rain came. This forestry and silviculture work is vital to the maintenance of our property and conducted in accordance with our property Conservation Easement and DNR-supplied Forest Management Plan.

100<sup>th</sup> Anniversary and the IWLA Defenders Award



At our February 13, 2024 Membership meeting, National Director Roger Moran presented to Frederick #1 Chapter President, Mike Morgan, a plaque from IWLA National commemorating the 100th anniversary of our Chapter. Frederick #1 Chapter celebrated our 100<sup>th</sup> anniversary in 2023. Moran also awarded our Chapter with the Izaak Walton League Defenders Chapter Achievement Award. This is only one of the 44 bestowed in 2023 from a field of 205 chapters nationwide. Chapters nominated for this award must meet or exceed at least five of the six broad award categories including membership growth, financial support, education, conservation, youth involvement, and outreach and communications during the 2022 calendar year.

#### **2024 National Convention**

Roger Moran, National Director, announced the 2024 IWLA National Convention will be held in Cambridge, Maryland at the <u>Hyatt Regency</u>.

This convention follows a new two-day format on Monday, July 15, and Tuesday, July 16. The Early Bird Welcome Reception will be Sunday evening, July 14. The Executive

Board and Endowment Board will also meet on Sunday. The Maryland Division is planning optional events on Wednesday, July 17, ranging from fishing trips to a tour of an oyster hatchery and research center. The convention's theme is Restoring Our Great Waters – Taking Action Today to Secure a Better Future

At the 2024 convention, the League will focus on our historic mission to protect the nation's great waterways, including the Chesapeake Bay, and discuss how we can take action today to secure a better future. We will also host a special event to celebrate the 100th anniversary of the League's 1924 achievement of establishing the Upper Mississippi River National Wildlife and Fish Refuge. ### When was the IWLA Frederick #1 Chapter chartered?



The National Izaak Walton League was formed in Chicago, Illinois in 1922. The Frederick Chapter was chartered in September 1923. To the best of our research, the Frederick Chapter was the first in Maryland and is one of the two oldest chapters in the nation. Fifty members signed the charter that

proudly hangs in the Chapter house on Reels Mill Road just outside of Frederick City. Hunter Bowers, remembers that hunting and fishing laws were just being established and it was often difficult to convince many outdoorsmen that seasons and limits were needed and must be lawfully enforced. The Frederick Chapter began to encourage outdoor and hunter ethics as early as 1923.

#### Maryland governor wants hurdle cleared for mega data center development in Frederick County

An administration bill aims to exempt Quantum Loophole and other developers from environmental regulation on large-scale backup power generation.

FREDERICK, Md. — Maryland Gov. Wes Moore says he's all in on bringing data centers into the state.

Moore's administration has introduced a bill that would clear a big obstacle out of the way for developers in Frederick County trying to get a controversial project back on track.

In October, data center developer Quantum Loophole had some of its plans to build a gigawatt-scale complex on 2,100 acres in southern Frederick County derailed by state energy regulators. Maryland's Public Service Commission denied waivers from environmental regulations to install a fleet of 168 backup generators, which combined could produce enough power to run more than a quarter million homes, a scale that rivals some big polluting power plants.

Developers argue the generators are for emergency use only and would not come with even a fraction of the same environmental impact as a 500 megawatt plant.

The PSC denial forced one of Quantum Loophole's first big data center tenants to pull out of its deal, which did not go over well with Gov. Moore. The governor spoke to a statewide conference of county leaders in December about his data center priorities.

"Yes means making Maryland the best place for businesses to invest in data centers and infrastructure that will drive the technology economy," Moore said to applause from the group.

The Moore administration has introduced a bill to change the law to exempt back up power for data centers from PSC regulations by declaring data centers critical infrastructure, like hospitals and fire stations.

Maryland Tech Council CEO Kelly Schulz, who also lives in Frederick County, said data centers are good businesses that don't come with the costs of other types of development.

"If you look at the impact on the community from a data center as compared to an entire new neighborhood of homes that need to be serviced through the community and the county, its not even a comparison," Schulz said.

Skeptical opponents have been showing up at meetings of a special Workgroup on Data Centers in Frederick County, which will release its recommendations for local regulation soon.

"You need to look at regulations not for what the public relations department of a data center company says," preservationist Steve Black, the president of the Sugarloaf Alliance, told the work group on Jan. 25. "You need regulations that hold them accountable to a certain floor of behavior,"

Chelsea Kadish, the chief of staff to county executive Jessica Fitzwater, leads the work group.

"What I'm worried about is this constant comparison to Loudoun County," Kadish told workgroup members in January. "We've decided we don't want to be Loudoun county. We do not want to be them."

In previous presentations, Quantum Loophole promised development that is master planned to prevent the sprawl of data centers seen in Loudoun County. But the company already needs exemptions from some state power regulations to even get started. Moore's bill to remove the hurdle has not yet received a vote by legislators.

#### Frederick #1 Chapter Forest Management



At our February Chapter Membership Meeting, Steve Meyer gave a presentation introducing the <u>Forest Stewardship Plan</u> (FSP) prepared by the Maryland Department of Natural Resources Forester, Thomas Keenan, that came from Keenan's two-day intensive assessment of our Chapter forest. In his presentation, Steve outlined a long-range plan, based on the

DNR recommendations, for removal of invasive tree and plant species, conducting silviculture activities, sowing wildlife food plots, and planting native species.



Steve also introduced plans to apply for State and Federal fund cost-share programs which are available to our Chapter because of the FSP. Please contact Steve Meyer with interest in participating in management of our forest and invasive species removal at <u>stephen.meyer7@gmail.com.</u>

IWLA Frederick Chapter #1 Save our Streams program provides testing and long-term water chemistry data on select streams in Frederick County Maryland. The Izaak Walton League's Save Our Streams program is the only nationwide program training volunteers to protect waterways from pollution and bring information about water quality to their communities.

<u>Save Our Streams</u> monitoring occurs each month from March to November currently alternating between Ballenger Creek and Tuscarora Creek. ### **Chapter History: Squirrel Box Contest**

DID YOU KNOW? In the early 1960s, the Frederick #1 Chapter sponsored a national competition to build a better squirrel box for supporting and increasing the squirrel population. At the time, squirrel populations were showing a steady decline as their homes were lost to timbering. The box would have to be one

that squirrels would readily enter, could withstand weather and the test of time, and could be constructed inexpensively for wide use by conservation groups. The contest featured \$1,000 in prize money [\$10,419 adjusted for 2024 inflation] and was nationwide in scope. Entries by the hundreds were received from across the country. The winner was from Michigan and the 2nd and 3rd places were taken by designers in Arizona and Wisconsin. The Wood Duck box program also received much attention as hundreds of nesting boxes were installed along stream bottoms. Learn more about our Chapter history at this frederickiwla.org link.

### **BOARD OF DIRECTORS NEWS**

### **Chapter Rules Changes & Reminders**

The following rule changes were finalized and adopted by Membership vote on November 14, 2023 and took effect January 1, 2024. The main purpose of these changes is to help entice new prospective members to join as well as ease the burden on current members.

**Objective**: To increase membership numbers and club participation by removing barriers which may hinder new members joining, renewing, or actively participating in club activities.

**Goal**: To distinguish our chapter from what similar clubs in the area can offer its members.

The following have taken affect January 1, 2024.

**Hunter Eligibility**: Goal is to promote increased participation of those members who take advantage of the club's hunting privileges.

Amend **Section 5:1 – Rules of The Hunt** – to add the following language:

- 1. Be a member in good standing (dues up to date)
- 2. Attend (4) or more monthly membership meetings prior to requesting their initial hunt for the season.
- 3. All hunters are required to complete points requirements regardless of age for the privilege of hunting the property. Members must complete 50% of their required points before they are eligible to sign up or hunt the club property.
- 4. Delete Section 4:4 May only hunt once a week. (Section 4:1 Location and Time Selection; already ensures a fair and ordered selection process. Limiting any member to hunt only once a week is arbitrary and capricious.)

**Membership Dues Reduction**: Goal is to evaluate barriers to new or continued membership with the need for club participation. The objective is to gain new members and maintain legacy members.

- 1. Introductory New Member 1st year due structure discount of 50% (Attracts new members without the financial burden or risk)
- 2. Remove any initiation fee. Currently it is \$75.00. (Again, this lessens the financial commitment to new members and potentially brings back old or lapse members who are opposed to having to pay the initiation fee again.)

**Service Hour Requirement**: Goal is to evaluate barriers to new or legacy members with the objective of increasing membership and participation. The objective is to gain new members and maintain legacy members.

Participation Requirement: Each member (or Family) is required to accrue 12

participation points annually.

- 1. Members earn 1 point for each monthly membership meeting attended (12 points max).
- 2. Members can earn 1 point for each sponsored activity attended (12 points max). This includes Conservation activities, Book Management, YHEC, and Course Instruction etc.
- 3. Members earn 2 points for each quorum critical meetings (Annual Budget & Annual Nominating meeting).
- 4. Members earn up to 4 points for each chapter designated event attended (Fund Raising, Recruiting, Division Meetings, Etc.). This can be pro-rated to include prep work, set-up, take down and clean-up.
- 5. Members earn 1 point for every hour they engage in a sponsored chapter workday.
- 6. Participation Points will be recorded utilizing the chapters established validation process.

Individuals: \$105 (current rate) – **AND-** 12 points earned –**OR-** \$260 (current rate)

\$157.50 (current rate) – AND- 12 points earned –OR- \$315 (current rate) Family

The Chapter By-Laws have changed to be in line with National rules requiring members to renew memberships by December 31 to remain in good standing.

The Frederick Chapter Board of Directors meets the second Tuesday of each month at 6:30pm just prior to the regular Membership Meeting. Members are welcome and encouraged to observe these open meetings which address the business of the Chapter. Members may bring up any issues they may have during the Membership Meeting directly after the Board meeting.


